### In 2015, the certification process at the American Osteopathic Association (AOA) began its 76th year. The certification process continues to be an important assessment tool for enhancing the quality of health care and protecting the public. Certification demonstrates a standard of excellence for osteopathic physicians, including quality of services and commitment to lifelong learning. In addition, many health care facilities and insurers require physicians to be board certified.

Since its establishment in 1939, the Bureau of Osteopathic Specialists, the official certifying body of the AOA, has issued 43,670 certificates, including primary specialties, subspecialties, and added qualifications (family medicine only). As of December 31, 2015, a total of 27,365 osteopathic physicians were currently certified by the AOA and held a combined total of 31,887 active certifications, representing a 2.4% increase over the number of active certifications held in 2014. In 2015, a total of 2176 certificates were awarded as follows:

- Primary specialty: 1896
- Subspecialty: 219
- Certificate of Added Qualification (family medicine only): 61

Additionally, 2001 Osteopathic Continuous Certifications (formerly referred to as recertifications) were issued in 2015. A complete list of certifications processed in 2015 and the total number of active certifications by specialty is found in the *Table*.

Since 2011, the number of active board certifications held has risen steadily (*Figure*). This number is expected to continue to rise in the future. (doi:10.7556 /jaoa.2016.051)


