### 709 Management of Primary Knee Osteoarthritis and Indications for Total Knee Arthroplasty for General Practitioners

As older adult and obese populations grow in the United States, physicians are likely to see an increase in patients with osteoarthritis (OA) of the knee. Although total knee arthroplasty (TKA) is a common treatment for patients with knee OA, nonoperative treatment options should be exhausted before TKA is considered. The authors look at the best nonoperative management options for knee OA, as well as surgical procedures that are less invasive than TKA.

# 716 Bibliometric Measures and National Institutes of Health Funding at Colleges of Osteopathic Medicine, 2006-2010

Colleges of osteopathic medicine (COMs) have made several advances in research; however, COMs obtain less funding than their allopathic counterparts. Therefore, understanding the factors influencing the attainment of extramural funds at COMs is highly warranted. The authors considered select bibliometric measures at COMs from 2006 through 2010 to determine whether associations existed between these measures and the amount of National Institutes of Health research funds awarded to COMs in 2006 and 2010.

# 726 Self-Reported Physical Health, Mental Health, and Comorbid Diseases Among Women With Irritable Bowel Syndrome, Fibromyalgia, or Both Compared With Healthy Control Respondents

To compare perceptions of irritable bowel syndrome (IBS), fibromyalgia (FM), and their co-occurrence, the authors used data from the Biopsychosocial Religion and Health Study survey, drawing on responses among women with IBS, FM, or both disorders (IBS plus FM) and a similarly aged control group with no IBS or FM. Survey questions focused on stressful life events, general physical and mental health, and general medical, pain, and psychiatric comorbidities.
